## Partners in Progress: Enhancing the Housing Choice Voucher (HCV) Experience for Nevada Landlords

### Join us for a Virtual Symposium

The Department of Housing and Urban Development's (HUD's) Landlord Task Force welcomes landlords to a Nevada virtual symposium. The symposium is designed to enrich the experience of Nevada landlords who participate in the HCV Program through a series of interactive sessions designed to amplify input from landlords and inspire collaboration between landlords and PHAs.

**Separate registration is required for both sessions.** The sessions are spread out over several weeks, which will allow organizers to fully integrate information from each session into the subsequent session(s). The sessions will be tailored specifically to the needs and interests of Nevada landlords. Landlords are invited to join sessions 1 and 3 as outlined below.

#### Session 1: Tuesday, September 14, 2021 | 1:00PM – 3:00PM Pacific Listening and Learning from Nevada Landlords: Landlords' Experiences with the HCV Program

The symposium kicks off with a landlord listening session. This session will begin with a brief overview of the HCV Program, but the majority of time will be dedicated to hearing from landlords about their experience with the HCV Program. The forum will use interactive polls to guide and focus discussion.

#### Session 2: Tuesday, October 19, 2021 | 1:00PM – 3:00PM Pacific Housing Authority Workshop: Building upon Strengths and Mitigating Challenges with the HCV Program

This session will share feedback gathered during the landlord listening session with PHA staff. The responses and commentary gained from landlords will provide the basis for a collaborative conversation about ways PHAs can best serve landlords who participate in the HCV program. PHAs can share best practices with each other while also exploring new ideas for addressing common challenges.

**Who should attend:** This session is for PHA staff only.

#### Session 3: Tuesday, November 2, 2021 | 1:00PM – 3:00PM Pacific Uniting Perspectives: Combining Landlord and PHA Feedback to Strengthen Relationships

The final session will connect landlords, PHAs, and HUD personnel with a comprehensive review of the content and outcomes of the previous two sessions. The session will also include discussion of ways landlords and PHAs can continue building relationships to improve the landlord experience.
